

It seems to have been supposed that the Act of 1872, chap. 316, which authorizes exceptions to be taken in criminal cases, also authorizes exceptions such as the one presented in this record. That Act can only apply to such rulings as the Court may be called upon to make with regard to the admissibility of evidence during the trial. It is impossible that the Legislature contemplated giving the right to parties in criminal cases to have instructions upon the law and the legal effect of the evidence, and exceptions to such rulings, in the face of the Constitutional provision under which juries are at liberty to treat such instructions with utter disregard, and to find their verdict in direct opposition to them. - . The imposition by the Act of 1872, ch. 234, of a tax of one-half of one per centum upon the gross receipts of all railroad companies worked by steam, incorporated by, or under authority of the State, and doing business therein, in lieu of all other taxes, is a valid exercise of Constitutional power.
